Enforcement and Compliance:

Metrc[®] the MED Marijuana Inventory Tracking System:

All operational MED Licensed Medical and Retail Marijuana facilities must have an active Metrc[®] account and have all inventory and plants associated with a RFID Tag prior to their first transfer or sale of marijuana or marijuana product inventory. Sections 309 of both the MED Medical and Retail Regulations address the use of the inventory tracking system - a copy of which can be reviewed on the [Laws and Regulations Page](#).
